Analysis of studies on the use of mechanical DVT methods has shown that general surgery patients on average have about a 9% chance of developing deep vein thrombosis (most of which are calf) if stockings or compression are used, compared with a 20% to 24% chance if no prophylaxis is employed. Also, due to Covid 19 & the vaccine, there has been an increase in deep vein thrombosis and there should be a program in place in every facility for every surgery patient.

Our processes lead to increased inpatient care, reduction of liability, and improvements in time management through the implementation of our DVT Prevention Program.



How Does the DVT Program Work?

Best Medical Solutions will bill and manage all your DVT inventory. Your facility staff no longer has to take time out of patient care to order, stock DVT units or cuffs. Frequently Asked Questions



- Q:** Why would I use a Durable Medical Equipment company to supply DVT prevention products such as calf cuffs?
- A:** Most facilities cannot bill DME products. There are limits on facilities with DRGs (Diagnostic Related Grouping) and this same issue applies to global fees for your facility. BMS is licensed in DME and we have our own product coding that lies outside of these limitations.
- Q:** Do we have a choice in the DVT cuffs that we use?
- A:** All decisions on products in your facility whether it is DME or DVT prevention are decided by your facility. We can also provide assistance in order to choose the best equipment that fits your facility.
- Q:** Why use BMS for DVT prevention?
- A:** We are accredited and we follow Medicare and all state and federal guidelines. All you have to do is ask and we will provide this information.
